Why Canada?

Innovation + Financial Stability + Gateway to the World = Profits

Innovation

Canada offers the lowest business costs in the G7 for R&D-intensive sectors, with a 27.7 percent cost advantage over the United States. Combined with Ontario's R&D programs, businesses can reduce their after-tax cost of every \$100 in R&D spending to between \$37 and \$61.

Financial Stability

With a strong, stable, dynamic economy, Canada is a financially safe place to invest and do business. The World Economic Forum consistently declares Canada's banking system to be one of the soundest in the world.

Gateway to the World

Once CETA is implemented, investors in Canada will gain preferential access to both NAFTA and the EU — vibrant markets with a combined GDP of nearly US\$37 trillion, or one-half of the world's output of goods and services.

According to fDi Intelligence's 2017 report on global greenfield investment, the Province of Ontario is a top three destination for capital investment in North America, after New York and California.




Competitive Business Costs

In Ontario, businesses benefit from highly competitive business costs that can boost a company's growth and profitability. With a total combined provincial and federal corporate income tax (CIT) rate of 26.5%, Ontario's combined general federal-provincial CIT rate is lower than the average of G20 countries and lower than the average federal-state CIT rate in the United States. As well, Ontario employers enjoy health costs half that of their counterparts in the United States.

Why Simcoe County?

Low Real Estate Costs + Access to Markets + Strong Transportation Network = Growth

Low Real Estate Costs

As the pace of development, congestion and land values continue to rise in the Toronto Region, development is increasingly migrating north to lower-cost communities in Simcoe County. The regional transportation network offers less congestion, lower volume of traffic and a strong secondary road network. According to a 2017 study by Deloitte, commercial and industrial land prices tend to be lower than in the comparative Greater Toronto Hamilton Area (GTHA) communities.

Access to Markets and Strong Transportation Network

Simcoe County's location, just north of Toronto, and transportation network provides businesses with seamless distribution access to global markets.

Modes of Transportation



Connected to the provincial and regional highways facilitating transport to Canadian and U.S. markets.



Home to Lake Simcoe Regional Airport with on-site Canada Customs that features a 6,001-ft runway. Toronto Pearson International Airport, Canada's largest airport, is located within one hour of Simcoe County.



Simcoe County is located just 45 minutes away from CPR Intermodal Terminal in Vaughan and CN Rail Intermodal Terminal in Brampton. Short-line rail service is also available and connects directly with CP Rail.




According to HONDA Canada, Simcoe County's highway access was a key driver of success in its logistics strengths. Railways and secondary roads with lower traffic were also identified as an important means to meet delivery requirements. The Lake Simcoe Regional Airport was also noted as important for just-in-time deliveries that required air shipment.



As well as Georgian College and Lakehead University and a number of private training institutions, there are five colleges and five universities approximately 30 minutes from Simcoe County. Annually, these schools produce more than 140,000 post-secondary graduates.


